Riverside Home Construction Update: September 2019

The Riverside Homes Preservation construction work is moving toward completion. Construction crews will finish work in Cedar-East and start work at Riverside Park during October. Work will continue in Riverside Park until February 2020. The work is intended to improve and preserve the affordable housing asset for the Cedar-Riverside neighborhood.

Crews have been busy installing new siding, windows, doors, and replacing old furnaces, and making a variety of safety improvements such as new electric panels, carbon-monoxide and smoke detectors, shock-preventing

kitchen and bathroom outlets, and removal of any identified lead paint hazards. Tenants of Block 40 (the block behind the African Development Center) spent the month of August without their parking lot as a new parking lot surface and rain garden were completed. Other significant site



work will occur soon as we redo the parking lot serving the ADA units at Riverbluff Townhomes, and improve a parking area in Riverside Park. We will also be installing a rain garden behind 621 19th Avenue soon.

If you live in a Riverside Park building, you've already had construction folks come through to measure for windows, and if they haven't done so already, Mutual Management will be contacting you to let you know when work is scheduled to begin on your unit and to identify your family's specific needs during construction.

Five of the six new accessible ADA compliant units are already completed, with one more being added in Riverside Park.

Cedar-Riverside program furthers work to reduce social isolation



The West Bank Community Development Corporation recently received a grant for its social programming for local women. Cedar-Riverside community leaders are using grant money to foster community for women living in affordable housing. The grant, awarded through the Blue

Cross and Blue Shield of Minnesota Foundation, provides more than \$66,000 toward the WBCDC's programming over the next two years. The program aims to decrease isolation among East African women in Cedar-Riverside. WBCDC, which owns around 500 units of affordable housing in the neighborhood, provides weekly programming to support the women in those units, such as gardening and field trips. Funding will go toward sewing instruction, cultural and art activities, neighborhood events, child care and more. Blue Cross Blue Shield Program Officer Bilal Alkatout said that WBCDC's programs made the organization a good candidate for the grant. More at www.mndaily.com.

CENTERPOINT COLD WEATHER RULE AND UTILITY ASSISTANCE

CenterPoint Energy is reminding customers about certain rights and their responsibilities as it relates to the Cold Weather Rule (CWR), which protects residential customers experiencing difficulty paying their natural gas bill from having their natural gas service disconnected between Oct. 15 and April 15, 2020. While the CWR does not prevent customers from being disconnected for nonpayment, it does provide customers extra protection as defined in the CWR, but residential customers must contact CenterPoint Energy to set up a payment plan.

Customers who anticipate having trouble paying their entire natural gas bill, have received a Notice of Proposed Disconnection or need gas service reconnected are all urged to call CenterPoint Energy to establish a payment plan. A payment plan will include what is owed as well as the amount to be billed and will take into consid-

eration a customer's financial situation and any other special circumstances. The payment plan

must also be agreeable to both the customer and CenterPoint Energy.

Under the CWR, special payment terms are available to customers who: 1) Apply for and receive Low Income Home Energy Assistance Program (LIHEAP) funding assistance in Minnesota, or 2) Meet income guidelines set by the state of Minnesota and provide proof of income.
